**NOTICE**

Section 17923 Business & Professions Code

- (a) Any person who is a general partner in a partnership that is or has been regularly transacting business under a fictitious business name may, upon withdrawing as a general partner, file a statement of withdrawal from the partnership operating under a fictitious business name. The statement shall be executed by the person filing the statement in the same manner as a fictitious business name statement and shall be filed with the county clerk of the county where the partnership files its fictitious business name statement.
- (c) The Statement of Withdrawal from Partnership Operating under a Fictitious Business Name shall be published in the same manner as the fictitious business name statement and an affidavit showing the publication of the statement shall be filed with the county clerk after the completion of the publication
- (d) The withdrawal of a general partner does not cause a fictitious name statement to expire if the withdrawing partner files a statement of withdrawal in accordance with subdivision (a) and (b) and the requirement of subdivision (c) is satisfied.

If the file number begins with an "R", your document should be filed in the Riverside office. If the number begins with an "I", your document should be filed in Indio. (See front of form for addresses)
